The City of Sparta is accepting bid proposals for the semi-annual purchase of pool chemicals and water and waste-water plant chemicals for the fiscal year beginning July 1, 2023 and ending December 31, 2023. Bid packages and information are available and can be obtained at Sparta City Hall, 6 Liberty Square, PO Box 30, Sparta, Tennessee 38583, telephone 931-836-3248. Sealed bids for <u>Chemical Bids</u> will be received until <u>2:00 p.m. on Tuesday June 6th, 2023</u> at which time the bids will be publicly opened and read aloud.

The City of Sparta reserves the right to reject any or all bids, to waive any irregularities in a bid, to make awards to more than one bidder, to accept any part or all of a bid, or to accept that bid, (or bids) which in the judgment of the Board of Mayor and Alderman of the City of Sparta is in the best interest of the City. The City of Sparta, Tennessee will receive sealed bids for the purchase of the following chemicals until 2:00 p.m. on Tuesday June 6th, 2023 at which time the bids will be publicly opened and read aloud. All items are F.O.B. Sparta, Tennessee.

Water Plant Chemical Specifications

- 1. Liquid Fluoride (Fluorosilicic Acid) 55 gals. drums. 12 drum purchase per delivery. Estimated use 4,500 gals. annually. Must deliver within 1 week of order date to Water Treatment Plant.
- 2. Sodium Hypochlorite12.5%-15% Maximum 1600-1800 gallons per delivery, approximately every 3 weeks. Estimated use of 26,000 gallons annually. Must deliver within 5 days of order date to Water Treatment Plant.
- 3. Kemira PAX-XL8 Approximately 46,500 lbs. per delivery, every 2 months. Estimated use 279,000 lbs. annually. Must deliver within 5 days of order date to Water Treatment Plant. No other product may be substituted!

Sewage Treatment Plant Chemical Specifications

- 4. Chlorine 150 lbs cylinders. Minimum delivery of 2 cylinders. Estimated use of 6 cylinders annually. Must deliver within 72 hrs. to Sewage Treatment Plant.
- 5. Sulfur Dioxide 150 lbs. cylinders. Minimum delivery of 2 cylinders. Estimated use of 12 cylinders annually. Must deliver within 72 hrs. to Sewage Treatment Plant.
- 6. Superfloc C-1598 Polymer 55 gal barrels Minimum delivery of 1 barrel. Estimated use of 12 barrels annually. Must deliver within 72 hrs. to Sewage Treatment Plant. No other product may be substituted!.
- 7. Calcium Nitrate 3,800 gal. dumped into 3 tanks located within the Sparta Collection System approximately every 2 months. Product must have the same chemical properties of existing product being used. Must deliver within 5 to 7 days to the locations above.

- 8. Sodium Hypochlorite 12.5%-15% 53-55 Gal. Drum 500 gal. min. delivery. Estimated use of 35,000 gal. annually.
- 9. Calcium Hypochlorite (granular) 100# drum One (1) drum minimum delivery. Estimated use of 200 lbs annually.
- 10. Muriatic Acid 20 Baume 32% 500# drum One (1) drum Minimum delivery to be used June through August. Estimated use of 5 drums.

For our convenience, we do not wish to pay deposits on cylinders or drums. Empty drums may be picked up when deliveries are made.

All bid prices shall be firm for the entire period of July 1, 2023 through December 31, 2023. The award of bids may be split between two or more companies depending on prices of individual items, for example; one company may only be awarded bid for one item.

For each item bid, please include MSDS. Please list any other fees & their rates that may be charged such as fuel surcharges, freight, etc. in "Misc. Info" space provided. The City of Sparta shall pay no fees unless included in vendor's bid.

Bids are to be addressed to the City Administrator and delivered to the Sparta City Hall, 6 Liberty Square, PO Box 30, Sparta, Tennessee 38583.

Bids must be enclosed in a <u>sealed</u> envelope and must be marked <u>"Chemical Bid"</u> on the front of the envelope. All bids must be signed.

Letters of certification must accompany all chemicals which differ from those that were previously approved for use in Sparta Water & Sparta Wastewater systems.
